**REFUND POLICY**

- All requests for refunds must be made in writing to Delta School District's Academy Program.
- Full refund of the tuition fee (less the \$200 application fee) if the Student Authorization is not approved by Canadian Immigration. The student must submit an original copy of the letter of rejection from the High Commission/ Canadian Consulate General/Canadian Embassy.
- Two-thirds (66%) of the tuition fee is refunded if the student withdraws prior to the start of the Academy program.
- One-half (50%) of the tuition fee is refunded if the student withdraws before the end of the first calendar month of the Academy program.
- No refund of the tuition is given (for any reason) after the student has attended the Academy for one month. This includes any tuition paid for future school terms.
- No refund of the tuition is made if the student is dismissed from the Academy program as a result of a breach of the terms and conditions of the agreement.
